### **Section 4 - First Aid Measures**

**Inhalation:** Remove source(s) of contamination and move victim to fresh air. If breathing has stopped, give artificial respiration, then oxygen if needed. Contact physician immediately. **Eye Contact:** Flush eyes with plenty of water. If irritation persists, seek medical attention.

# **Section 5 - Fire-Fighting Measures**

Unusual Fire or Explosion Hazards: None known.

**Fire-Fighting Instructions:** Use water spray to cool fire-exposed surfaces and to protect personnel. Shut off "fuel" to fire. If a leak or spill has not ignited, use water spray to disperse the vapors. Either allow fire to burn under controlled conditions or extinguish with foam or dry chemical. Try to cover liquid spills with foam.

**Spill /Leak procedures:** Spilled material may produce dust hazard if not handled correctly. Wear appropriate personal protective equipment: coveralls, gloves and eye protection. **Storage Requirements:** Keep container(s) tightly closed and properly labeled. Store in cool, dry, well ventilated place away from heat, direct sunlight, strong oxidizers and any incompatibles. Store in approved containers and protect against physical damage. Keep containers securely sealed when not in use. Indoor storage should meet OSHA standards and appropriate fire codes. Containers that have been opened must be carefully resealed to prevent leakage. Empty containers retain residue and may be dangerous. Avoid water contamination.
